Chapter 79.â€”TAXATION

1 The Confederation shall levy a general consumption tax based on the system of net all-phase taxation with input tax deduction (Value Added Tax). The purpose of the tax is to tax non-business end use on Swiss territory. 2 As Value Added Tax, it levies: a. a tax on goods and services supplied for consideration by taxable persons on Swiss territory (domestic tax);
